(e) On April 29, 2008, the stockholders of L-3 Communications Holdings, Inc. (the Company) approved the 2008 Long Term Performance Plan and 2008 Directors Stock Incentive Plan (together, the Plans) at the Company s annual meeting of stockholders. The Plans became effective upon such stockholder approval. Approval of the L-3 Communications Holdings, Inc. 2008 Long Term Performance Plan and Proposal 3.
