Mr. Dauch holds options exercisable within 60 days of 12/31/07 to acquire 1,554,500 shares. Mr. Dauch is president of the Richard E. and Sandra J. Dauch Family Foundation, a charitable foundation under Internal Revenue Code Section 501(c)(3), which owns 411,710 shares as of 12/31/07.

Richard E. Dauch disclaims beneficial ownership of all shares held by the Sandra J. Dauch Gift Trust dated May 25, 1998, of which his spouse is trustee and beneficiary.
