(3) An option to purchase 30,883 shares of the Issuer's Common Stock was issued to the Reporting Person under the Issuer's 2005 Omnibus Equity Plan. 7,720 shares of Common Stock become exercisable on October 24, 2013 and an additional 7,721 shares of Common Stock become exercisable on each of October 24, 2014, October 24, 2015, and October 24, 2016.
