(1) On September 14, 2005 (the "Trade Date"), TA IX L.P. entered into a Forward Sale Transaction (the "Transaction") with an unrelated third party (the "Buyer") relating to 12,019,137 shares of Common Stock. The maturity date of the Transaction is September 14, 2007, subject to acceleration in certain events. TA IX L.P. will receive a payment from the Buyer in the amount of \$20.28 per share (after provision for financing costs which are subject to adjustment) within three business days of the Trade Date.
