On August 16, 2017, Mr. Norman H. Pond, the Company's Founder and Chairman of the Board of Directors (the Board), notified Intevac, Inc. (the Company) that he was retiring from his service as director and Chairman of the Board, effective as of such date.

In connection with Mr. Pond's retirement, the Board has appointed Mr. David S. Dury to assume the role of Chairman of the Board, and Mr. Thomas M. Rohrs will replace Mr. Dury as Chairman of the Audit Committee, with each appointment effective as of August 16, 2017.
