(1) An option to purchase 200,000 shares at an exercise price of \$0.7875 was granted on December 22, 1997. The option vests over a four year period with 25% vesting on December 22, 1998 and continuing an additional 6.25% in quarterly equal installments thereafter and fully vested on December 22, 2001.

(2) This option was originally reported as covering 50,000 shares at an exercise price of \$3.15 per share, but was adjusted to reflect the stock splits on June 26, 2000 and September 11, 2001.
