(1) Each deferred unit is the equivalent of one share of the Company's common stock. On August 10, 2011, 1,862.826 of the reporting person's deferred units were settled for cash, based upon the Company's closing stock price on the New York Stock Exchange on August 5, 2011.

(2) One third of the options will become exercisable on March 1, 2012, an additional one third of the options will become exercisable on March 1, 2013 and the remaining one-third of the options will become exercisable on March 1, 2014, the third anniversary of the grant date.

(3) The restricted unit award will be settled in cash on the third anniversary of the grant date (May 3, 2010) based on the Company's closing stock price on the New York Stock Exchange on the expiration date.

(5) One-third of the deferred unit award will be settled in cash as soon as practicable, and in any event within 90 days, after the first, second and third anniversaries of the grant date (August 6, 2010) based on the Company's closing stock price on the New York Stock Exchange on the applicable anniversary date. Deferred units are fully vested when credited.
