(1) Grant of 20000 restricted shares under the 2003 Plan as amended, restated and adopted with a four year quarterly vesting schedule as to the lapses of restrictions thereof with 1/16 equal portions (1250 shares) vesting quarterly with the next 1/16 vesting on April 1, 2015 and thereafter equal 1/16 portions on April 1, July 1, October 1 and January 1 each year with the final 1250 shares on January 1, 2019.

(2) Includes 20000 restricted shares above and includes 24,208 restricted shares granted under the Company's equity plans for which restrictions have not lapsed.
