Restrictions lapse in 16 quarterly installment with the first 15 installments of 1,021 shares each beginning on April 1, 2017 and thereafter with 1,021 on April 1, July 1, October 1 and January 1 of each year with the final 1,035 shares lapsing on January 1, 2021.
