On June 17, 2013, Ashford Hospitality Trust, Inc. ("Ashford Trust" or the "Company") held a conference call to discuss a plan to spin-off an 80% ownership interest in an 8-hotel portfolio, totaling 3,146 rooms (2,912 owned rooms), to holders of Ashford Trust common stock in the form of a taxable special distribution.
