  - (1) The reporting person elected to defer receipt of 1076 shares of common stock issuable upon the exercise of his options, resulting in the accrual to his account of 3147 shares of phantom stock of which 2071 of those shares were used to pay for the exercise price. The stock expires upon the termination of the Deferred Compensation Agreement which remains in effect until the reporting persons retirement or the agreement is otherwise terminated.
  - (2) For options granted in any one year, one-seventh of the options of such grant vest and become exercisable on the grant date of the anniversary each year commencing on the first anniversary after the grant.
  - (3) Options expire 3 years after vesting.
  - (4) Mr. Funke also owns 5153 exercisable options which are part of his 2003 Stock Options.
