Portugal Telecom Announces Issue of 20-Year Eurobond

Lisbon, Portugal, 3 June 2005 - Portugal Telecom, SGPS, S.A. (PT) announced today that it has successfully issued a Euro 500 million Eurobond, with a maturity of 20 years, through its wholly-owned subsidiary PT International Finance.

Following the completion of this transaction and the issue of Euro 1,500 million Eurobond in March of this year, the average maturity of PT s debt has been extended to approximately 7.5 years.

The proceeds will be used to fund the acceleration of 3G rollout in Portugal, to fund post retirement obligations related to additional staff curtailment, and to provide PT with additional financial flexibility, by reducing the use of commercial paper and standby lines.

Citigroup was the sole book-runner of this transaction.

PT has a rating of A3 (stable) by Moody s and A- (stable) by S&P.
