Old National Bancorp's wholly owned bank subsidiary, Old National Bank ("ONB"), entered into branch purchase and assumption agreements to sell three banking centers as part of its ongoing efficiency improvements and market transformation. ONB entered into an agreement with River Valley Financial Bank to sell the deposits and banking center facility in Osgood, Indiana. ONB also entered into an agreement with MainSource Bank to sell the deposits at its Hope and Greensburg, Indiana banking centers and its banking center facility in Hope, Indiana. The branch sales are subject to regulatory approval and customary closing conditions. ONB expects the transactions to close in December of 2013. ONB does not expect these divestitures to have a material impact on its financial statements.
