(1) On November 3, 2007, restrictions lapsed with respect to 12,500 shares of restricted common stock held by Mr. Hodous. Pursuant to the terms of his restricted stock award, he elected to surrender to the Company 4,469 of such shares in order to satisfy the resulting withholding tax obligation. As a result, as of that date Mr. Hodous held 33,500 shares of restricted common stock and 8,031 shares of common stock.
