Carr were subject over the past two weeks to the forced sale of all of the remaining approximately 4.3 million shares of the Company's common stock that they owned directly. As previously announced March 2, 2009, these shares were pledged as security for a loan and the shares were sold by the lender without any action by Mr. and Mrs. Carr. These sales are in addition to the forced sale of 692,412 shares announced at that time.
