- On March 16, 2009, Ms. Lassa was awarded 230,000 shares of service-condition vesting restricted stock under the Boise Inc. The first 20% of this 2009 award (46,000 shares) vested on March 15, 2010, and Ms. Lassa elected to have shares withheld to satisfy her tax withholding obligation.
