On January 12, 2015 the last reported sale price, NAV per Common Share and percentage premium to NAV per Common Share, were \$13.56, \$13.44 and 0.89%, respectively. As of January 12, 2015, we had 23,732,967 Common Shares outstanding and net assets of approximately \$319,045,850.

The following replaces the last sentence in the first paragraph under Use of Proceeds in the Prospectus Supplement:

Assuming the sale of all of the Common Shares offered under this Prospectus Supplement and the accompanying Prospectus, at the last reported sale price of \$13.44 per share for our Common Shares on the NYSE as of January 12, 2015, we estimate that the net proceeds of this offering will be approximately \$15,315,817 after deducting the estimated sales load and the estimated offering expenses payable by the Trust.
